### Summary of matter to date

Follow up as per Council direction on February 20, 2013

#### **Update**

I have attempted to arrange the review of the MDS documents. The plan was to have the 3 parties meet on site to review the measurements submitted for the Zoning By-Law Application 11-18FR. However John O'Neill indicated he was unable to attend but would submit information on the MDS Application. Therefore Mr. Benvenuti stated that Mr. Bouffard's Planner Paul Goodridge was not welcomed on his property. The Hebert's declined to comment saying they were waiting to speak with their lawyer. The intent of having our CBO Al McCann attend was as an observer to the process, giving Council a clearer sense of the data results of the proposed MDS review. It appears that our efforts have failed to move the parties. I have emailed information to Council to keep you abreast of the actions. I have excluded Councilor Mike Bouffard as he has indicated that he has a conflict with Zoning By-Law Application 11-18FR.
