#### **3.2 Delegation Request by Linda Duff Presentation by Capt. R. Nadon - Army Cadets North Bay Detachment**

Mrs. Duff gave a brief introduction of the Army Cadet Program and introduced those who were present for the Delegation.

amended to allow two delegations at the Regular Meeting of Council.

A descriptive overview of the program was given, the major points mentioned were that the program is fully supervised, there are no costs to the families, all the required equipment is provided and the program is for youth ages 12 to 19. The goal is to recruit the youth at the age of 12 to allow them to fully take part in the levels of the program but the youth would not be turned away because of his or her greater age.

The feasibility of the program depend on local sponsorship (from local clubs and groups) to pay for expenses (approx.. \$3,000 per year), the recruitment of at least 15 youth, the demographics show an anticipated viability of the program (future recruitment), a building (such as the Alban Community Centre), a support committee comprised of volunteers to hold positions such as president, vice president and treasurer and the support and commitment of the parents of the youth.

The goal is to have the Army Cadet program set up and running for the month of September.

Further information will be advertised in local newspapers and available at local events.

#### **3.3 Delegation Request by Michel Raymond of the French River Nurse** Practitioner - Led Clinic Presentation of the Nurse Practitioner - Led Clinic and introduction of the Nurse Practitioners and Executive Director

Nicole Ranger, the Executive General Manager of the French River Nurse Practitioner - Led Clinic gave a descriptive overview of the model of health care that will be provided.

The tentative opening of the clinic is July 2012; the community will be kept up to date of the opening and the calling of patient applications in News Releases in the local newspapers as they are currently doing. The updates can also be provided to the municipality to be included on the Municipal Website. The members of the board of directors were introduced as well as the nurse practitioners who were present.

Mrs. Ranger explained the method of patient applications which will be done in phases, patients from the Town of Alban that are un-attached (with no health care provider) will be accepted first. The new clinic does not have access to the patient waiting list that is currently held at the clinic located in the Town of Noëlville; patients will have to re-apply.

French River Nurse Practitioner - Led Clinic is not funded as a walk-in clinic, it will be set up for minor procedures, however procedures to deal with emergency walk-in patients will have to be discussed and established.
